



Legislative Authority

- ➤ July 2, 1957 A resolution by the Roane County Quarterly Court authorizing the creation of a Civil Defense Organization in Roane County, naming John C. Gower as director.
- ➤ July 15, 2003 A resolution by the Roane County Commission to require training for the Hazardous Materials Response Program under the requirement of OSHA 29 CFR 1910.120.
- ➤ August 11, 2004 Resolution #08-04-09 to change the name of the Roane County Emergency Management Agency to The Roane County Office of Emergency Management and Homeland Security.
- ➤ August 11, 2004 Resolution #08-04-10 to adopt National Incident Management System (NIMS).
- ➤ June 16, 2008 Resolution #06-08-08 to create the Roane County Office of Emergency Services and the Roane County Fire Department.

TN Office of Homeland Security

- ➤ Created in April 2003 by the Governor of Tennessee
- Designed to foster regional approach to terrorism prevention, preparedness, and response
- ➤ Divided in **11 districts** Roane County is in **District 2**
- ➤ District 2 is the **largest district** Knox County and 15 contiguous counties
- ➤ Roane County's special assigned mission is technical expertise in the hazardous material field of radiological/nuclear terrorism for the District 2 first responder community

District 2 Homeland Security Council

- Consists of one voting member from each member county(16).
- Conducts hazard and threat analysis for the district.
- Leverages the Department of Homeland Security's grant money to build capabilities to combat the hazards and threats in the district.

Roane County Fire Department (Where We Started)

- >2007 Directive to Emergency Management by County Executive to assist volunteer fire departments to lower ISO fire rating
- >2008 Study on rural fire suppression service completed by EMA/CTAS >Study findings:
 - ➤ Manpower shortage per ISO requirements
 - ➤ Inadequate response times per ISO requirements
- ➤ 2008 Roane County Commission creates Roane County Fire Department and combines with EMA creating the Roane County Office of Emergency Services
- ≥2008 Roane County Commission levies fire tax

What We've Done/Doing

- Fire Hydrants number and cost
- Hired 2 full time and 4 part time firefighters stationed at Midtown VFD
- OES Staff respond to all structure fires and are trained firefighters
- Purchased equipment (examples)
- Increased contract payments to VFD's 2010
- ISO evaluation assistance
- ISO reduction for East/Midtown
