GRANT ACTION PLAN MEETING

- Gets all of the key players in one room
- Lets everyone know purpose, scope and individual responsibilities
- Has a sign in sheet so each person acknowledges their role and the requirements set forth by each other



GRANT TRACKING WITHIN CAPITAL FUND

- If a grant is for a large amount, or for a project that will span multiple fiscal years, we use sub funds within our General Capital Projects Fund for tracking.
- These budgets are appropriated on a project basis, and as such do not need to be reappropriated each fiscal year.
- Using a sub fund provides individual balance sheet, revenue and expenditure tracking for each grant.
