The RCERB meeting was called to order by Chair Koltowich at 5:30 pm. The program was presented in three parts.

- Ms. Eimer gave an update on what has transpired since the December 22, 2008 ash spill. Ash recovery has stopped. The ash pond has been stabilized and is now a CERCLA waste disposal cell. The cell is scheduled for closure in 2015.
- Mr. Zeller gave an overview of the general environmental health in and around the TVA Power Station. He explained the tools used to evaluate the ecological health of the area. He then went over the collected data. The data tends to show that the removal of the majority of the ash from the Emory River and the Swan Pond Slue, along with isolating the ash remaining in the failed ash pond is working.
- The final part of the presentation was a visit to the site to see the old ash pond (now a waste storage cell) and to get an overview of what is being done to reclaim the area for public use and wildlife habitat.
