Subject: American Rescue Funds

Ladies and Gentlemen,

I wanted to give you an update on the \$10,368,828 of the Rescue Funds.

### Approved by Commission:

- Establishing a Subfund in the General Capital Project Fund 171- ARP
- Appropriated the \$10,368,828 as a total, but not for projects
- \$1,000 Bonus for Covid Essential Workers within the Appropriation Resolution #06-21-02B
- \$1,157,000 for Riley Creek Resolution #05-21-11

### Actions Taken:

- Commission Workshop and PowerPoint of Direction June 10, 2021
- \$5,181,414 has been received

### Recommended Action- Filed for Commission consideration for August 2021 Commission Meeting

- **Master Resolution** for managing the ARP Subfund- The Master Resolution states that individual projects will be voted on by commission and the resolution outlines the guideline to be used, but also states that commission has final approval for projects which could fall outside the guidelines
- At least seven (7) projects will be submitted on prescribed forms:
  - #1- \$1,000 Bonus equals \$325,000
  - #2- \$416,000 Ambulances and Equipment
  - #3- \$1,157,000 Riley Creek
  - #4- \$200,000 HVAC at Health Department
  - #5- \$700,000 East and Harriman Ambulance Stations
  - #6- \$300,000 HVAC at Sheriff/Jail
  - #7- \$325,000 HVAC at Courthouse
- Other projects are in the works, but are not ready to be submitted for consideration.
- Total additional Anticipated Request is estimated over \$12 million, which includes Primary Government Operations and partnering with Non-government entities of Utilities and Broadband vendors.

Attached you will see our filed resolution with the attached blank form. Also attached is the #1 -\$1,000 Bonus to show you how we are filing the projects. All projects (#1 through #7) will be in your commission packet.
