All documents must be originals or certified. Photocopies will not be accepted.

### Acceptable Documents for U.S. Citizenship or Legal Presence- MUST Present One (1):

- Official Birth Certificate issued by a State Office or Vital Statistics or equivalent with a raised seal and/or color seal
- U.S. Certificate or Consular Report of Birth Abroad (DS-1350 or FS-240 or FS-545)
- Valid, unexpired U.S. Passport or Passport Card
- Certificate of Citizenship (N-560 or N-561)
- Certificate of Naturalization (N-550, N-570 or N-578)
- Valid, unexpired 10 year Permanent Resident Card issued by DHS or INS (I-551)

**ANY NAME CHANGES MUST BE VERIFIED BY A LEGAL DOCUMENT: MARRIAGE CERTIFICATE - DIVORCE DECREE - COURT ORDER- THIS MAY REQUIRE PRESENTATION OF MULTIPLE DOCUMENTS**

### Acceptable Proof of FULL Social Security Number and Name- MUST Present One (1):

- Social Security Card (metal cards not acceptable)
  - Payroll Check Stub
  - W-2 form for current tax year or dated within last twelve (12) months
  - 1099 Form for current tax year or dated within last twelve (12) months
- 

### Acceptable Documents for Proof of Domicile- MUST Present Two (2):

- Current utility bill including telephone, electric, water, gas, cable, etc. (includes "bundle" packages)
- Current vehicle registration (*personal vehicle not company vehicle*) dated within the last 12 months
- TN vehicle title showing TN address (*but can't use a title and vehicle registration as both proofs*).
- Mortgage papers - such as the property deed or mortgage payment coupon/book
- Copy of Lease Agreement or Contract with notarized signatures OR accompanied by signed realty agency letterhead confirming lease validity.
- Voter registration **card** - **NOT** the application for voter registration.
- Military LES papers listing Tennessee as home of record (*This is ONLY document that won't have the address - you are looking for confirmation that the military has their HOME OF RECORD as TN.*)

\*Current filed tax return - not tax return booklet. (*E-filed returns that include the W2 form AND confirmation page are acceptable only if dated within the last 12 months.*)

**REMINDER: ALL CDL LICENSE HOLDERS ARE REQUIRED TO HAVE A VALID DOT MEDICAL ON FILE WITH OUR DEPARTMENT OR IN THEIR POSSESSION AT THE TIME OF VISITING ONE OF OUR DRIVER SERVICE CENTERS FOR A SERVICE.**
